It was moved by Kennedy, seconded by Homolka, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The school district treasurer's financial report disclosed a reconciled unencumbered balance of \$3,950,315.07 as of August 31, 2024.

The high school activities fund account disclosed a balance on August 31, 2024 of \$341,678.11, middle school activity fund disclosed a balance of \$19,151.45, and the elementary activity fund disclosed a balance of \$22,105.41. The cafeteria account disclosed a balance \$36,271.92.

The Board Reviewed policies 5046, 5047, 5048, 5050 and 5051 with no Changes.

It was moved by Homolka, seconded by Zikmund, to approve the 2024-2025 Fiscal Year Budget. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.

It was moved by Kennedy, seconded by Heins, to approve the Resolution to Increase the District's Base Growth Percentage by up to an additional six Percent. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.

It was moved by Homolka, seconded by Heins, to approve the 2024-2025 School Year Tax Request Resolution for Central City Public Schools. NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is at \$8,964,646.00 (2) the Tax Request for the Bond Fund should be, and hereby is set at \$555,556.00 (3) the Tax Request for the Special Building Fund should be, and hereby is set at \$712,121.00 and (4) the Tax Request for the Qualified Capital Purpose Undertaking Fund should be, and hereby is set at \$0. It was moved by Kennedy, seconded by Homolka, to Approve the Resolution on School District Standards for Acceptance and Rejection of Option Enrollment Applications. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.

It was moved by Kennedy, seconded by Zikmund, to Approve the Purchase of a Route bus to be delivered during the 25-26 Fiscal Year. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.

The Board discussed, but took no action, on 2025-2026 Certified Staff Negotiations.
